

**ACADEMIC
Non-Exclusive Software Licence Agreement**

The MIAKAT™ software as may from time to time be updated by Imanova Limited (“Imanova”), (“the Software”) has been developed by Imanova and certain contributing researchers and other institutions (“the Developers”) and is made available by Imanova for your internal, non-profit use.

Imanova and the Developers allow the named individual that has been provided with the MIAKAT™ software (“you”, “your”) to run, display and modify the Software on the following terms:

1. Conditions of Use

- 1.1.** The Software remains with you and shall not, without the express permission of Imanova, be published, distributed, reproduced, modified, transmitted or otherwise transferred in any form or by any means, electronic or mechanical, or made available to anyone other than you
- 1.2.** If, through the use of the Software, you: make any results available to other academic researchers for non-profit research purposes; or publish any results, you agree to acknowledge the contribution Imanova, the Software and any modifications makes to your research and to cite appropriate references in your publications.
- 1.3.** You agree to keep in the Software and any modifications to the Software, the copyright, trademark, or other notices pertaining to the Software as provided by Imanova.
- 1.4.** You are not permitted under this licence to use the Software for commercial purposes, which shall be defined as use for which any financial return is received, directly or indirectly, including: integration of all or part of the source code or the Software into a product for sale or license by or on your behalf to third parties; use of the Software or any derivative of it for research with the final aim of developing software or non-software products for sale or license to a third party; or use of the Software to provide any service to an external organisation or person for which payment is received. If you wish to use the Software for commercial purposes, including fee-based service projects or studies or projects funded or part funded by a commercial sponsor, you will need to execute a separate licensing agreement and pay a fee. - 1.5.** Imanova reserves the right to inspect and have access to any premises (and to the computer equipment located there) at or on which the Software is being kept or used, and have access to any records kept in connection with this licence, for the purposes of ensuring that you are complying with the terms of this licence, provided that Imanova provides you with reasonable notice of such inspections, which shall take place at reasonable times.
- 1.6.** You acknowledge that the Developers, Imanova and its licensees (the “Imanova Parties”) may develop modifications to the Software that may be substantially similar or functionally equivalent to your modifications and improvements, and that the Imanova Parties shall not be constrained in any way by you in their use or management of such modifications; if you obtain patent protection for any modification or improvement to the Software you agree

not to allege or enjoin infringement of your patent by the Imanova Parties obtaining modifications or improvements to the Software from Imanova.

- 1.7. Where you choose to provide Imanova with feedback on the use or development of the Software, including by provision of any modifications to, improvements upon and/or derivative works of, the Software (“Feedback”), the Imanova Parties shall have a perpetual, irrevocable, royalty-free, worldwide right to make, have made, sell, offer for sale, import, use, reproduce, distribute, prepare derivative works of, publicly perform and publicly display such Feedback in any media now known or hereafter known, whether for commercial or non-commercial purposes and including in any release by Imanova of the Software.

2. Intellectual Property Rights

- 2.1. As between you and Imanova, the Software remains the property of Imanova. You shall have no rights in or to the Software other than the right to use it in accordance with the terms of this licence.

3. As-Is Warranty, Limitation of Liability and Indemnification

- 3.1. Any risk associated with your use of the Software is with you and your institution. The Software is experimental in nature and is made available under this licence solely for non-commercial use as a research courtesy "AS IS," without obligation by Imanova to provide accompanying services or support.
- 3.2. Imanova expressly disclaims any and all warranties, representations, terms and conditions regarding the Software, whether express or implied, including but not limited to those pertaining to non-infringement, accuracy, or fitness for a particular purpose or use under specific conditions.
- 3.3. Neither Party excludes or limits its liability for: (a) death or personal injury caused by its negligence, or that of its employees, agents or sub-contractors; (b) fraud or fraudulent misrepresentation by it or its employees; (c) breach of any obligations as to title implied by section 2 of the Supply of Goods & Services Act 1982; or (d) any other liability to the extent the same may not be excluded or limited as a matter of law.
- 3.4. Imanova shall not be liable under any circumstances for any losses or damages directly or indirectly incurred under or in connection with this licence, whether consequential or otherwise, and whether arising in contract, tort (including negligence) or otherwise, including but not limited to loss of profits, loss of business opportunity, loss of goodwill or loss or corruption of data.
- 3.5. You agree to indemnify, defend and hold harmless Imanova, the Developers and its respective officers, employees and agents from and against any and all third party claims, damages and liabilities (including claims for negligence) arising directly or indirectly from the use of the Software or the sale of any products based on the Software.

4. Other

- 4.1.** Imanova may terminate this licence at any time if you fail to comply with any of its terms. On such termination, you must destroy all copies of the Software you received or made under this licence. Clauses 1.5, 1.6, 2 and 3 above shall survive termination of this agreement.
- 4.2.** This agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the laws of England and Wales. Each party irrevocably agrees to submit to the exclusive jurisdiction of the courts of England and Wales, save that nothing shall prevent either party from seeking injunctive or other equitable relief in any court of competent jurisdiction.
